### **Residential Activities** San Diego County - June 2020

- Apartments 90%+ Collections
- Rent-up of new projects going slowly, particularly downtown high-rises.
- Apartment resale activity continues, albeit slower than usual.
- Construction and sale of New "For Sale" projects continues big-time,

despite "appointment only" sales offices.

New Residential Construction – Permit Activity almost equal to 2019

(through May).


